Terms and Conditions

- Subject to the remainder of these terms and conditions customers can claim the cash back amount on HP Qualifying Printer and Print Cartridges purchased between 1 May and 31 July 2008. The printer must be purchased at the same time as the additional print cartridges on the same invoice in order to qualify. Customers may claim cash back for a maximum of 10 qualifying HP printers during the period of the promotion.
- To take advantage of the promotion, customers must print out and complete the claim form (which can be downloaded at www.hp.com/uk/cashinwithcolour and send it, along with proof of purchase in the form of the seller's invoice to the address set out in the claim form. Proof of order or dispatch note will not be accepted. The seller's invoice must clearly show the customer details, qualifying products purchased, the purchase price and the date of purchase. The participant must not send original receipts. HP must receive the claim form within 30 days from the date of purchase.
- The promotion is valid in respect of qualifying products purchased either directly from HP or an authorised reseller or authorised retailer of HP. The promotion is only valid for end user customers (i.e. customers purchasing products for their own use); claims where the products purchased will be resold or rented to a third party are ineligible for this promotion.
